



## TERMS & CONDITIONS

### Foundation for Arable Research (FAR) Arable Photo Competition 2022

#### COMPETITION SUBMISSIONS

1. All photos must be submitted via email to [admin@far.org.nz](mailto:admin@far.org.nz). There is no limit of photos per person or per award category.
2. It is the photographer's responsibility to obtain consent from all photographed persons and owners of recognisable photographed property, including consent to these terms, for photos submitted to the Arable Photo Competition.
3. The photographer gives permission for all photos submitted to be used by FAR and grants an irrevocable royalty-free licence to FAR to store all photos submitted, use all photos free of charge in any of its online and print publications for an indefinite period, noting that once printed, images are permanent. Photos may be cropped, enlarged, or digitally reproduced either individually or in a group of photos at FAR's discretion. The photographer will be acknowledged where practicable.
4. Submission of a photo is deemed acceptance of these terms.

#### COMPETITION CRITERIA

5. All photos submitted to the FAR Arable Photo Competition between Friday 23 September and Sunday 30 April 2023 will be eligible for the FAR Arable Photo Competition.
6. Category winners and the grand prize winner will be selected at the end of the competition period and will be published in FAR's quarterly From the Ground Up newsletter. The decision is final and no correspondence will be entered into.
7. Photos submitted to the competition must be of suitable resolution and image quality (minimum 3MB) for reproducing a high-quality print.
8. Competition winners will be notified by telephone or email within 14 days of the competition ending.

#### COMPETITION PRIZES

9. Prizes will be awarded to winners of each of the five competition categories and a single grand prize will be awarded to the overall winner.
10. Inability to contact the winner within 14 days of selection will result in the prize being forfeited and an alternative entry will be selected to receive the prize.
11. The prizes are not exchangeable or transferable except as expressly stated.

#### GENERAL

12. Employees of FAR, its associated companies and advertising agencies are ineligible to submit photos to the Arable Photo Competition.
13. FAR collects and holds participants' personal information solely for the purpose of receiving and using photos and conducting the Arable Photo Competition and will only use or disclose personal information in connection with this.
14. Submitters to the Arable Photo Competition winners consent to their name and city/town of residence being used for public relations purposes.
15. FAR is not responsible for photos that go astray. If participants fail to adequately fill out the submission form and/or submit a photo, it will not be accepted into the Arable Photo Competition.
16. Except for any liability that cannot be excluded by law, FAR and its suppliers exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the submission of photos, or the competition.
17. FAR reserves the right to cancel or amend any aspect of these terms and/or the Arable Photo Competition at any time.
